

Instructions: National Scholarship Program Application

A. The Criteria for the Scholarship is as Follows


- The RCMP will award annually, 50 scholarships of \$1000.00 (each), to direct dependents of regular, civilian, retired or former members of the RCMP (including CSIS) for academic excellence in any discipline of further education, in a full time course of study at a post-secondary school leading to a degree or diploma.
- 2. The applicant may apply if they are under the age of 25 years and are already attending a Canadian university or college on a full time basis.
- 3. Applicants must be enrolled in a Canadian university, community college or cégep.
- 4. Applicants must achieve a minimum average of 75 percent in the graduating year of secondary school to qualify. If final marks are unavailable by the cut-off date, mid-term marks will be accepted. However, submission of final marks is required when received.
- 5. Applicants must have community leaders/teachers provide a letter of support (maximum one page) that displays how they have made a **significant**, **voluntary contribution** as a member of their school and/or community.
- 6. Submit your application between May 1st and no later than July 15th, applications postmarked on July 15th are acceptable.
- 7. Previous recipients of an RCMP National Scholarship Program Award cannot re-apply.

B. Completion Instructions

- 1. Attach the one-page letter of reference describing your community/school volunteer work.
- 2. Attach an official transcript from your secondary school. Do not send university or college transcripts.
- 3. Incomplete forms will not be considered.

C. Other Information

- 1. Only award recipients will be advised.
- 2. Payment will be made to the university/college upon proof of registration.
